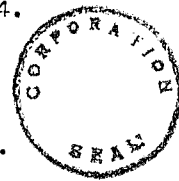

KNOW ALL MEN BY THESE PRESENTS, That Greenville Spartanburg and Anderson Railway Company, a corporation duly organized and existing under and by virtue of the laws of the State of South Carolina, in consideration of the sum of One Thousand Dollars (\$1,000.00) and other good and valuable considerations to it in hand paid at and before the sealing of these Presents, by Piedmont and Northern Railway Company, a corporation duly organized and existing under and by virtue of a Special Act of the legislature of the State of South Carolina, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Piedmont and Northern Railway Company, its successors and assigns, all the following property, rights, privileges, franchises and easements, situated and located in the State of South Carolina, to-wit:

(1) All that certain tract, piece or parcel of land, situate, lying and being in the County of Greenville, State of South Carolina, a short distance without the corporate limits of the City of Greenville, and bounded and described as follows, to-wit:

Beginning at a stake on the North side of Cedar Land Road in line of property of Greenville, Spartanburg & Anderson Railway Company, being fifty-one (51) feet Southeast of the center line of the track of the Greenville, Spartanburg & Anderson Railway Company's line; and running thence with the North line of said Hampton Avenue Extension South forty-seven (47) degrees forty-five (45) minutes East one hundred twenty-five (125) feet to a stake; thence along line parallel with and twenty-five (25) feet distant from the center line of the proposed spur track of the Greenville, Spartanburg & Anderson Railway Company, approximately South forty-three (43) degrees ten (10) minutes West to a stake in the line of the property of the Greenville, Spartanburg & Anderson Railway Company; thence with said line North twenty-six (26) degrees thirty (30) minutes East two hundred fifty-seven (257) feet to a stake; thence still with line of Greenville, Spartanburg & Anderson Railway Company North thirty-four (34) degrees eighteen (18) minutes East four hundred twenty-five (425) feet to the beginning corner, containing one and eight one-hundredths (1.08) acres, more or less, and being the property conveyed to the Greenville, Spartanburg & Anderson Railway Company by Theron Earle, by deed dated the 25th day of April 1913, and recorded in the office of the Register of Mesne Conveyances for Greenville County, South Carolina, in Volume 18, page 249.

(2) All that certain tract, piece or parcel of land situate, lying and being in the County of Greenville, State of South Carolina, and bounded and described as follows, to-wit:

Beginning at an iron pin, middle of Washington Road, and edge of right of way of Greenville, Spartanburg & Anderson Railway Company; thence with middle of Washington Road North thirty-five (35) degrees fifty-four (54) minutes West three hundred twelve (312) feet to pin in middle of concrete arch of Fertilizer Branch; thence with said Branch North eighty-one (81) degrees twenty (20) minutes East two hundred twenty-eight and eight-tenths (288.8) feet to an iron pin in Branch; thence with said Branch North sixty-nine (69) degrees twenty four (24) minutes East one hundred twenty and six-tenths (120.6) feet to an iron pin in branch; thence with said branch North fifty-one (51) degrees forty-eight (48) minutes East fifty-eight (58) feet to an iron pin in edge of right of way of Greenville, Spartanburg & Anderson Railway Company; thence with said right of way South thirty-one (31) degrees fifty (50) minutes West by station 1405 plus 81.2; thence continuing with -
