in consideration of the sum of Twelve hundred & fifty DOLLARS,
to me in hand paid at and before the sealing of these presents by Rebecca C. Honour

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Rebecca C. Honour, All that lot of land on Pendleton Road just beyond the incorporate limits of the City of Greenville, S.C. and near Brandon Mills, known as No. 6 Honour's Row- measuring on Pendleton Road beginning at No. 5- 60 ft. west to No. 7, thence South two hundred ft. (200 ft.) to Southern Ry. right-of-way, thence East 60 ft. more or less to lot No. 5, thence North 200 ft. more or less to Pendleton Road, being same land conveyed to me by Charles Seegmore Honour Feb. 15th, 1910 and recorded Vol. 8, page 434 June 20, 1910.
