KNOW ALL MEN BY THESE PRESENTS, That I, Thos. N. Scott, of the County of Greenville in the State aforesaid

in consideration of the sum of Six hundred and thirty & no/100 DOLLARS, to me in hand paid at and before the sealing of these presents by

W.M. Norwood (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

W.M. Norwood, his heirs and assigns all that certain lot or parcel of land situate just outside of the corporate limits of the City of Greenville, County and State aforesaid, known as lots numbers 113- 114- 115- 116- and 121- in plat of survey of land of W.M. Norwood known as Norwood Heights made by J.N. Southern, Surveyor bearing date of October 9th, 1906, and recorded in Plat book A. on page 133. in office of Register of Mesne Conveyance for Greenville County.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said W.M. Norwood, his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
