KNOW ALL MEN BY THESE PRESENTS, That I, Bessie Edens, of Greenville County
in the State aforesaid
in consideration of the sum of one hundred twenty-five and no/100 (\$125.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by Ed Harrison

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Ed Harrison, All that piece, parcel or lot of land situate in Greenville Township, Greenville County, State of South Carolina, known as "Freetown", near the Cox Bridge Road, about three miles from Greenville Court House, being part of lot conveyed to me by B.M. McGee, and bounded by lands of Prof. J.M. Harris, Goodlett, and others, and fronting seventy-five (75) ft. on a road with a depth of one hundred twenty-five feet (125) and containing one-fourth (1/4) of an acre, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Ed Harrison, his heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Ed Harrison, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
