KNOW ALL MEN BY THESE PRESENTS, That I, Calvin A. Burrell
in the State aforesaid
in consideration of the sum of Fifty DOLLARS,
to me in hand paid at and before the sealing of these presents by Dydema E. Burrell

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Dydema E. Burrell, All my right, title and interest in all that piece, parcel or lot of land in Glassy Mountain Township, Greenville County State of South Carolina, about Seven miles west of Tryon, N.C. near Rocky Spur Mountain, containing one hundred acres, more or less and being a portion of the tract granted by the State to Richard Brassell Grant, recorded in book I, number 5, page 292 in the Secretary of State at Columbia and bounded by lands of H.J. Haynsworth, W.C. Lindsey and others for a further description see deed recorded in the office of Register of Mesne Conveyance for Greenville County in Book Z, page 489, being the same conveyed to me by William G. Serrine, April 29th, 1908. With all rents to support me my life time.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Dydema E. Burrell, her heirs and assigns forever heirs and assigns forever.

AND I do hereby bind myself heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Dydema E. Burrell

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
