D. Case tract and also a corner of J. Henry Trammells; thence S. 2 E. 36.00 ch. to a stone on the B. F. Holley line; thence N. 60-1/2 E. 24.20 ch. to a stone, thence N. 30-1/2 W. 32.50 ch. to a stone; thence S. 53 W. 7.50 ch. to the beginning corner, adjoining lands B. F. Holley estate of J. D. Case, G. J. - Southern, John L. Poole and others; containing fifty (50) acres, more or less.
