for and in consideration of the sum of Five hundred eighty five dollars, 50085 DOLLARS,
to me in hand paid at and before the sealing of these presents by

G.W. Metcalf of Greenville Co. S.C. (the receipt whereof
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

G.W. Metcalf a certain tract or parcel of land lying and being in Glassy Mountain Township
on branch waters of Mill Creek waters of South Pacolet River. Beginning on a pine 3x
running thence S. 26 W. 19.42 ch. to a pine 3X; thence S. 29 W. 14.54 ch. thence to a pine
thence S. 47-1/2 E. 53 ch to a stone thence S. 37 W. 5.75 ch to a stone in ridge road thence
with said road S. 47-1/2 E. 1.87 ch. to a stake 3X in ridge road S. 43-1/2 E. 3.25 ch. thence to

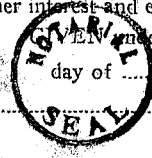
