KNOW ALL MEN BY THESE PRESENTS, That I, Joshua Lindsey
in the State aforesaid
in consideration of the sum of Twenty two and one-half DOLLARS,
to me in hand paid at and before the sealing of these presents by

Malinda Howard (the receipt whereof
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Malinda Howard, a certain piece or parcel or lot of land situated in the State aforesaid,
Greenville County on waters of South Pacolet River/ river in Glassy Mountain Township
containing nine acres, also a house on the cliff, more or less. Beginning on a walnut on the branch thence down the branch
to the bend of the branch thence straight to a locust corner at the road thence the road to
the rock corner thence the old road to the rock corner, thence back down the new road to a
Locust thence straight to the beginning walnut corner or beginning corner.
I Joshua Lindsey do give to Malinda Howard to have a ditch to run water through from the
branch through part of the land.
