Baylus J. Bruce of the State and County aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Baylus J. Bruce all of that certain piece, parcel and lot of land situate, lying and being in the State and County aforesaid near the Town of Greer, adjoining lands of Baylus J. Bruce, W.P. Vaughan and others, having the following metes and bounds: Beginning on a stone 3XOM, thence S. 14-1/2 E. 6.05 c to stone, thence N. 72-1/2 E. 2.27 to stone, thence N. 35 W. 6.33 to the beginning, containing three-fourth acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Baylus J. Bruce, his heirs and assigns forever.
