KNOW ALL MEN BY THESE PRESENTS, That I, Waddy O. Thompson

in the State aforesaid

in consideration of the sum of Five (\$5.00) DOLLARS,

to me in hand paid at and before the sealing of these presents by Hagar Ann Thompson my mother and also in

consideration of the love and affection I have for my said mother (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Hagar Ann Thompson all my undivided interest in all that piece, parcel and lot of land situate in the State and County aforesaid and City of Greenville, lying on Echols and Pinkney Streets, and bounded by lots of B.W. Hughes, W.A. Allison and lot conveyed by Allen Thompson, deceased to Jennie A. Dart by Deed bearing date the 18th day of December 1888, and recorded in the office of the Register of Mesne Conveyances for said County in Book UU, page 733, and being the same lot of land conveyed by Harriett B. McBee, Guardian and F.B. McBee and V.E. McBee to said Allen-Thompson by deed bearing date the 3rd day of December 1873, and recorded in the office of the Register of Mesne Conveyances for said County in deed book EE, page 208, except the said lot so conveyed to the said Jennie A. Dart as aforesaid; the said lot contains one-third of an acre, more or less, exclusive of what has been conveyed to the said Jennie A. Dart as aforesaid.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Hagar Ann Thompson, her heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Hagar Ann Thompson, her

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
