

Henry Briggs DEED TO J.R. Cleland

STATE OF SOUTH CAROLINA,

COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, Henry Briggs of the County of Greenville, and

in the State aforesaid

in consideration of the sum of Eight hundred and no/100 DOLLARS,

to me in hand paid at and before the sealing of these presents by J.R. Cleland

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.R. Cleland, all that piece, parcel and lot of land, situate lying and being in the First Ward of the City of Greenville, State and County aforesaid, and having the following metes and bounds to wit, Beginning at an iron pin on the South side of Mulberry Street, Russell's corner, and running with said Street N. 61-1/4 E. fifty one (51) feet to an iron pin, thence S. 37 E. one hundred and thirty four (134) feet to an iron pin, thence S. 57 W. fifty one (51) feet to an iron pin (Russell's back corner) thence N. 37 W. one hundred and thirty eight (138) feet to the beginning corner, being a portion of the land conveyed to me by G.W. Burbage and J.H. Burbage by their deed bearing date the 10th day of October 1905, which is recorded in the office of Register Mesne Conveyance, for Greenville County, Book 0.0. 0., page 645.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

J.R. Cleland, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J.R. Cleland, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
