KNOW ALL MEN BY THESE PRESENTS, That I, J.E. Roe of the County of Greenville and

in the State aforesaid

in consideration of the sum of Twenty two hundred and twenty and no/100 DOLLARS,

to me in hand paid at and before the sealing of these presents by

Joel T. Roe, of said County and State (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Joel T. Roe and his heirs and assigns forever, all that certain tract of land known as Lot No. five in the division of the real estate of H.D. Roe, Deceased, situated in the County and State aforesaid, on the North side of South Tyger River in O'Neal Township and having the following described metes and bounds, to wit: Beginning at stone corner of Lot No. 4, and thence N. 86 W. 20.99 to stone on line of Lot No. seven; thence S. 12-1/2 W. 15.00 to stake on River, corner of Lot No. seven; thence with the meanders of said river about 31.00 to stake, corner of lot Number Four; thence N. 5-1/2 E. 31.25 to the beginning, containing 55-1/2 acres, more or less, adjoining lots 3, 4, and 7, and being the same tract, this day conveyed to me by J.E. & Joel T. Roe, Executors of the will of H.D. Roe, decd.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
