(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Albert S. Johnstone, all that piece, parcel or lot of land, on which are two dwellings and other improvements, situate, lying and being in Ward One of the City of Greenville and in the County and State aforesaid, on the East side of Mulberry Street, beginning on a stake 3 x 0, which is 1.91 chains from the corner of Mulberry and Pinkney Streets and running from said stake S. 58 W. 1.37 chains to a stake 3 x 0, to a stake in the middle of an alley; thence S. 30-1/2 E. 3.03 chains to a stake 3 X 0; thence N. 52-1/2 W. 1.40 chains to a stake 3 X 0; thence N. 30-1/2 W. 2.90 chains to the beginning, or stake, SAid lot contains forty one hundredths of an acre (41/100) more or less, and is the same property conveyed to us by Robert C.
