KNOW ALL MEN BY THESE PRESENTS, That Markley Realty Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of ten dollars and other valuable consideration DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

W. B. Traxler, All that piece, parcel or lot of land in Greenville County, State of South Carolina, is the City of Greenville, on the west side of South Main Street, beginning at an iron pin on line of South Main Street, which pin is the southeast corner of lot no. 2 on the plat hereinafter referred to; thence N. 69-30 W, 110 feet to an iron pin on an alley; thence with line of said alley S, 20-30 W, 66 feet to an iron pin on line of lot no. 6; thence with line of lot no. 6 S, 69-30 E, 110 feet to a point on line of South Main Street; thence with line of said Street N. 20-30 E, 66 feet to the beginning corner, being known as lots nos. 3, 4 and 5 on the plat of Markley Realty Company, made by J. E. Surrine, dated March 26th, 1914, and marked N. B. 261.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

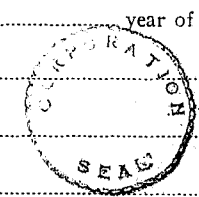
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinafter named, and his heirs and assigns forever.

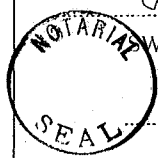
