KNOW ALL MEN BY THESE PRESENTS, That Piedmont Mortgage Company, Successor to Piedmont Realty Company, a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of two hundred ^{no.} _{no.} DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto R. M. Hampton

all that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, about one and one half miles north of the City of Greenville, in the village of Oakwood, having the following metes and bounds: Beginning at an iron pin on the southwest side of Pierce Street, at corner of lot No. 77 on plat hereinafter referred to, which lot is owned by Southern Power Company and running thence with line of said lot S. 48-30 W. one hundred eighty three feet to an iron pin on a fourteen foot alley thence with said alley S. 41-30 E. fifty feet to an iron pin; thence N. 48-30 E. one hundred eighty three feet to an iron pin on Pierce Street, and thence with Pierce Street N. 41-30 W. fifty feet to the beginning corner, being the northwestern portion of lot No. 76 as shown on plat of Oakwood made by J.
