KNOW ALL MEN BY THESE PRESENTS, That Realty Corporation

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Ten (\$10.00) Dollars and other valuable considerations DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Nancy D. Fennell, All that certain lot of land situate on the North side of Mooney Road in the County of Greenville, State of South Carolina in sub-division known as "Paris" being Lot #14 in Block "D" of said sub-division and more particularly described as follows:

Beginning at a stake on the North side of Mooney Road, a short distance from the intersection of said Mooney Road with Paris Mountain Road, at corner of lot #15, and running thence N. 45-35 E. 70 feet to a stake on said Mooney Road, corner of lot #13, thence along the line of lot #13 N. 0-30 E. 322 feet to the northern corner of lot #13 on the line of J. Lee Green; thence along said line N. 72-30 W. 460 feet to a stake, corner of lot #15; thence along the line of lot #15 S. 57-05 E. 630 feet to stake the beginning corner on said Mooney Road, said lot being bound on the North by lands belonging to J. Lee Green; on the East by Lot #13; on the South by Mooney Road and on the west by Lot #15. The plat of said land is recorded in the office of the R.M.C. Greenville County in Plat Book "C", page 87.
