KNOW ALL MEN BY THESE PRESENTS, That Geesville Real Estate Loan +
Insurance Company,
 a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at
Geesville, S.C. in the State of South Carolina, for and in consideration of the
 sum of \$16,000.00 DOLLARS,
 to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby
 acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto T. R. Long,

"All that certain tract or parcel of land, lying and being
 in the Town of Geesville, State and County aforesaid,
 and having the following metes and bounds, viz: Beginning
 at the corner of Railroad track T.R. Long's corner, running
 thence with rail road track N. 25° 21' 400 feet to center
 of new cut road, thence with said road S. 62° 24'
 635 feet to center of Laurens Road, thence with said
 road S. 6. to T.R. Long's corner 522 feet, thence with said
 line N. 70° 21' 463 feet to the beginning corner, containing
 five (5) acres, more or less and being the same
 tract of land conveyed to Geesville Real Estate
 Loan + Insurance Company by J. A. Blakey by

 thereof.
