KNOW ALL MEN BY THESE PRESENTS, That Piedmont Savings & Trust Company a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of Four Hundred and Fifty DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

H. H. Alberson, Jr. | All that piece parcel or lot of land situate, lying and being, in Subdivision known as West Park, just outside the City of Greenville, S. C. said tract being known as lots Nos. 335 and 336 as shown by plat of West Park, recorded in Plat book C, at pages 79 and 80, in R. M. C. Office for Greenville County. This being a portion of a tract of land conveyed to us by Piedmont Savings and Investment Company, by deed dated Dec-15-1916, recorded in Vol. 35 page 353, and having been conveyed to Piedmont Savings & Investment Company by W.
