KNOW ALL MEN BY THESE PRESENTS, That The Carolina Loan & Trust Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Six Hundred (\$600.00) DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

M.C. Burns, All that certain lot of land in the City of Greenville, County and State aforesaid, being one of the lots conveyed to the grantor by the will of John G. Eagle, deceased, deed recorded in Vol. 52 page 115 in P.M. Office of Greenville County, said lot has the following metes and bounds, Beginning one hundred forty seven and one half (147 1/2) feet from an iron pin corner of lot of Susan Mitchell in Brance Street and running thence parallel with Brance Street N 66 1/2 E Sixty six (66) feet, eight inches to an iron pin in line of Susan Mitchell's lot thence South 28 1/2 E Seventy (70) feet to an iron pin in corner of above lot thence 61 1/2 E Sixty six (66) feet eight inches to an iron pin in corner lot formerly known as T. D. Donaldson's lot N 28 1/2 E 70 feet to the beginning corner

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee, hereinabove named, and his heirs and assigns forever.
