KNOW ALL MEN BY THESE PRESENTS, That *J. Thomas C. Raine*
 in the State aforesaid
 in consideration of the sum of *One hundred forty four and 4/100* DOLLARS,
 to *me* in hand paid at and before the sealing of these presents by *J. N. Ross*
 (the receipt whereof
 is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J. N. Ross all that tract of land situate, lying and being
 in O'Neal Township, County and State aforesaid, on waters
 of Clear Creek, South 29th of River, and containing twenty-
 eight (28) acres, more or less, and having the following
 notes and bounds: Beginning at a point 3x0m. Mrs. Polly
 Bartaux's corner and running thence S. 66¹/₄ E. 16.40 to a
 stone 3x0. Mrs. Williams' corner thence with said Williams
 line N. 26¹/₂ E. 17.60 to a stone 3x0m. (for logrod); thence N. 66¹/₄
 W. 6.58 to a stone 3x0m. in a branch (pine pole, old pointer);
 thence S. 26¹/₂ W. 17.42 to the beginning corner, adjoining lands
 of Mrs. Williams, Mrs. Polly Bartaux and others, the same
 being tract No. 6 of the division of the land of George M. Stewart
 on a plat made by J. N. Crother, April, 11th 1895
