(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

F. C. Cox all that certain piece, parcel and lot of land situate, lying and being in the County and State aforesaid near the City of Greenville, S. C., in said Division known as Melrose and designated as Lot No. 11 in Block D, and a part of said Melrose property, and being the same lot of land which was conveyed to me by A. S. Clyde, Trustee for P. S. Butler, bankrupt, by deed dated the 2nd day of June 1912

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
