(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

E. H. Miller all that certain piece, parcel or lot of land, and being in the town of Greenville and state aforesaid, having the following metes and bounds: Beginning at an iron pin before the east side of Miller Street, corner of Mattie B. McClatchey corner, and running with Miller Street 80 feet to an iron pin; thence with W. F. Smith line 121 feet to an iron pin on Mr. B. F. Ture's line; thence with Mr. B. F. Ture line 80 feet to an iron pin, Mattie and Mattie B. McClatchey corner; thence with the line 121 $\frac{1}{2}$ feet to the beginning corner, containing nine thousand seven hundred square feet more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
