 in consideration of the sum of *Five Dollars and other valuable consideration* DOLLARS,
 to *me* in hand paid at and before the sealing of these presents by *C. C. Good*

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

C. C. Good, his heirs and assigns forever, all that certain piece parcel, or lot of land situated, lying and being in City of Greenville, County, and State aforesaid and known as Lot #13 on a plat made by F. G. Rogers, Surveyor on May 13th, 1912. Said lot fronted on Calhoun Street, and being the same lot of land conveyed to me by C. C. Good, by deed bearing date the 7th day of March, 1908 and recorded in the P. M. C. office for said County in Book Vol. 24 at page 471.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *C. C. Good, his* heirs and assigns, forever.
