KNOW ALL MEN BY THESE PRESENTS, That J. D. Lawford of Green

in the State aforesaid  
in consideration of the sum of six hundred DOLLARS,  
to 2000 in hand paid at and before the sealing of these presents by J. B. Henson

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J. B. Henson, all that certain parcel and lot of land situate and being in South Carolina, Greenville County in Parcel No. 1000 on the east side of Jordan Road and having the following meter and bounds to wit: Beginning at a point in center of Jordan Road (from pin on east side of said road) and run thence N. 43-30 E. 21-25 chs to a stone 34; thence S 89 1/2 W 9 chs to a stone, J. B. Henson old corner thence S. 43-30 W-15. 47 chs to a stake on east side of Jordan Road thence down said Jordan road with J. Stone line to the beginning corner 7 chs said tract containing thirteen and one tenth acres (3 1/10) with same more or less, this being a part of the land conveyed to me by J. G. Bonar, by deed dated June 14th, 1913. Recorded for Vol. 19 at page 559 in office R. M. B. in and for Greenville County and described by a plat thereto attached and prepared by W. H. Spink Aug. 14th, 1913 which is made a part hereof.
