County of Greenville, and in the State aforesaid
 in consideration of the sum of One thousand (1,000.00) DOLLARS,
 to me in hand paid at and before the sealing of these presents by

W. P. Payne

(the receipt whereof
 is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said
W. P. Payne, and his heirs and assigns forever: All that certain piece
 parcel or lot of land situate, lying, and being in the State
 of South Carolina in the City and County of Greenville, Ward
 five, and being known and designated as Lot No. three (3)
 according to a plat thereof made by Wm. A. Huston, D.S. Surveyor
 date January 29th, 1907, and having the following lines and
 bounds to wit:

Beginning at a stake on Watson Avenue, joint corner of lots
 No. 3 and 4 on above mentioned plat, and running thence
 along joint line of said lots No. 2 and 3, N. 71° E. 728 feet to
 a stake on Watson Avenue, thence along said Avenue about
 N. 18° 47' 55" feet to the beginning corner, the being a portion
