in consideration of the sum of *Nine* DOLLARS,
to *me* in hand paid at and before the sealing of these presents by *Rachel Lindsey*

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Rachel Lindsey, A certain piece or parcel of land lying and being in the State and Co of aforesaid and in the *Glassy Mt Township*, on the branch waters of *South Backlet*. Beginning on a *Chesnut 3X* thence up the *Mt Keill road* to a *red Oak 3X* thence *S. W.* to a *Walnut 3X* thence *S. E.* to the *be tree 3X* thence *N. E.* to a *Stone 3X* thence up the road to the beginning corner, containing by estimation five acres be the same more or less

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *Rachel Lindsey* heirs and assigns, forever.
