of Greenville, near the Eastern limits of the City of Greenville, in the vicinity of what is known
as Nickletown, and being known as lots Nos. 22 and 23, of Block "A" of Jefferson Heights, as shown
by plat recorded in Register of Mesne Conveyance office for Greenville County, in plat book "C",
pages Nos. 34 and 35. This being a portion of the Five lots deeded to me by D.B. Traxler, and
