KNOW ALL MEN BY THESE PRESENTS, That I, W.B. Parson

in the State aforesaid
 in consideration of the sum of One thousand DOLLARS,
 to me in hand paid at and before the sealing of these presents by J.K. Gault

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J.K. Gault, all that piece, parcel or tract of land situated and being in Fairview Township State & County aforesaid, lying on the East side of the Road leading from Mountain Inn to Stone's Old Mill; adjoining lands of W.T. Thackston & said J.K. Gault. Beginning at a stone in said road and thence along the said road N. 5-3/4 E. 7.81 to the Bend, thence N. 10-1/4 E. 8.00 to stone in the plat, on said road, thence S. 76-1/4 E. 2.94 to a cedar stake, thence S. 34-3/4 E. 8.58 to W.O. 3X, thence S. 72-3/4 E. 2.55 W.O. 3X, thence S. 13 E. 6.10 to a stone 3X in on the Thackston line, thence S. 25-1/2 W. 9.56 to stone 3X, thence N. 52 W. 12.03 to the beginning corner, the same containing Nineteen acres, more or less.
