Busey Simmons (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said Dr. W. Busey Simmons, All of that certain piece, parcel or lot of land situated, lying and being in the County and State aforesaid and bounded by lands of W. Busey Simmons, Mrs. Loella Welbourn and R. L. Simpson and having the following metes and bounds to wit.
