by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W. Carroll McDaniel and his heirs and assigns forever all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, in Saluda Township, containing twenty-two (22) acres more or less adjoining lands of Mrs. Lezie Cleveland, M. H. Hays and others and being the same tract of land conveyed by G. P. Charles and W. A. McBrayer to me, the said Sora A.
