by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Sallie A Green, her heirs and assigns forever, the following  
described real estate to-wit: All that certain piece, parcel and  
lot of land situated lying and being near Mingo-haw Mill on  
the west side of the City of Greenville County and State aforesaid,  
and being known and designated as lot number sixteen  
(6) on a plat made by R. C. Patton Surveyor on June 9th 1910 and  
recorded in the P. M. C. Office for Greenville County State aforesaid  
in plat book A. at page 409 and having the following
