(the receipt whereof is here-by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said J. H. Ponder, all that certain lot, piece or parcel of land situated in O'Neal township, County and State aforesaid on branch tributary to Beaver dam Creek Waters of Middle Tyger River.

KNOW ALL MEN BY THESE PRESENTS, That H. R. Deal, in the State aforesaid in consideration of the sum of Five Dollars (\$5.00) and other valuable considerations to me in hand paid at and before the sealing of these presents by W. S. Barr,

(the receipt whereof is here-by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W. S. Barr, all my undivided one half interest in that certain lot of land near the City of Greenville, County and State aforesaid, known as part of lot No. 34 Block 16 of Sans Souci Villa, and having the following metes and bounds, to wit: Beginning at an iron pin on the eastern side of Brockman Avenue, corner of lots 34 and 35 and running thence along line of lot 35 S. 57-25 E. 175 feet to an iron pin; thence S. 10-30 W. 62 1/2 feet to an iron pin; thence N. 57-25 W. 175 feet to an iron pin in Brockman Avenue; thence with Brockman Ave. N. 10-30 E. 62 1/2 feet to the beginning.
