by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said O. B. Simmonson an undivided one half interest in and to all those two lots of land situate, lying and being in Greenville Township in Greenville County and in South Carolina, being all of lots one (1) and two (2) in block "C" (except a strip of lot two (2) acre feet wide adjoining lot three (3) of Buist land according to plat thereof recorded in Plat Book #1, page 10 in the office of the Register of Deeds Conveyance for said Greenville County, having the following lines and bounds: Beginning at the south east corner of Mountain View Avenue and Towner Street, thence with Mountain View Ave., South 80.15 E., 200 feet to alley; thence with alley S. 45 E., 130 feet to iron pin on alley one foot from the present corner of lot three (3); thence N. 80.15 W., 200 feet to Towner street; thence with Towner street N. 9.45 E., 180 feet to the beginning corner. This deed is intended to convey all the undivided interest that we hold as executors in said two lots, except the one (1) foot strip of lot two (2) adjoining lot three (3) and vests the said O. B.
