KNOW ALL MEN BY THESE PRESENTS, That Hendrix Rector of the County and State aforesaid in consideration of the sum of Five hundred and seventy-five and 00/100 DOLLARS to me in hand paid at and before the sealing of these presents by Anna P. Nichols

(the receipt whereof is here by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Anna P. Nichols, All that certain tract or lot of land in Greenville County, State of South Carolina, known as lot 15 Block A as shown on a map of the Mountain View Land Company survey of W. A. Adams, recorded in State Books "A" pages 396 and 397, with lot containing sixty (60) on Bismarck Road and adjoining lot 14 on the west side of Bismarck Road one hundred and seventy-two feet (172) to a ten foot alley, thence with said alley thirty-two feet (32) to a stake, thence one hundred and sixty-five feet (165) to a stake on Bismarck Road, thence corner lots nos. 14 and 15; thence with Bismarck Road sixty feet (60) to the same lot conveyed to S. S. Hungerford (the receipt whereof is here by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said H. S. Hungerford, his heirs and assigns, All that lot or parcel of land situated in the City of Greenville, State and County aforesaid, on the East Side of Bailey St. fronting fifty (50) one and one-half feet on said Bailey St. and having a depth of one (105) hundred and eighty-five feet and containing seven (7677) thousand six hundred seventy-seven (6677) square feet more or less, being the northeast half from West Washington St. of the lot conveyed to W.
