All that certain piece, parcel or tract of land situate lying and being in the State and County aforesaid, O'Neal Township, and having the following boundaries to-wit: Beginning at an I. P. Enoch Howell corner and run thence Eastward 243 1/2 feet to gully I. P. the use Northward with said gully 492.1 feet to I. P. thence Westward up branch 119-6 feet to point I.
