KNOW ALL MEN BY THESE PRESENTS, That we, N.H. Harris, Sallie Hart Harris, Edna E. Willis, F.M. Harris, G.G. Harris, Mary H. Willis, Susan H. Pilcher and Nona H. Squires, in consideration of the sum of sixteen thousand dollars (\$16,000.00) to us in hand paid at and before the sealing of these presents by H.T. Mills (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H.T. Mills, all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the Fifth Ward of the City of Greenville, having the following metes and bounds, to-wit:

Beginning at a stake on the south-east corner of Calhoun and Garlington Streets, and running thence along said Garlington Street S. 74° E. to a stake on the corner of Garlington and Memminger Streets; thence with said Memminger Street S. 16° W. to a stake on line of land formerly belonging to James MacPherson; thence along the old MacPherson line N. 78° 20' W. to a stake on Calhoun Street; thence along Calhoun Street N. 16° E. to the beginning corner; this being the same tract of land conveyed to us, by J.M. Harris, by deed bearing date the fourth day of February, 1915. *3425*
