Jackson and Anna-Jackson, All my right, title, interest, estate, claim and demand whatsoever, both at law and in equity, in and to all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, in the Fourth Ward of the City of Greenville, Beginning at a state on the north side of East McBee Avenue, some distance east of Heldman Street, on the corner of the lot now or formerly owned by Charley Harris; and running thence with line of said lot N.172° E. one hundred and sixty (160) feet to a stake; thence S.72° E.forty-eight (48) feet to a stake on corner of lot now or formerly belonging to George Parker; thence along line of last mentioned lot S.172° W. one hundred and fifty-nine (159) feet to a stake on East McBee Avenue; thence along said Avenue N. 72° W.forty-eight (48) feet to the begining corner, this being the same lot of land conveyed to me, the said O.P.Mills, by Victoria White (by T.C.
