WHEREAS, our mother, Floride L. Stone, late of the County and State aforesaid, among other things, in her last Will and Testament, dated May 24th, 1911, admitted to Probate December 30th, 1914, recorded in Book L. at page 196, provided as follows:

I Will and devise to my seven remaining children to have and to hold absolutely and in fee simple, one lot each on the lawn of the homstead place, It is my desire that my son Eugene Stone, shall have the lot facing Croft Street, where the walnut trees are; my son J. Bennett Stone, the lot facing Earle Street, on which the carriage house is situated, The remaining five children to choose their own lots, and my daughter Floride Stone Miller, having the privilege of first choice, Each lot so divided to be of the same size and dimension as the one bequeathed my son Charles B. Stone, in the preceeding paragraph,"

AND, WHEREAS, the land therein referred to has been divided into lots and a plat made thereof, which is hereto attached and made a part of this agreement,

AND, WHEREAS, we, the undersigned, being the persons named and referred to in the Will above mentioned, and all being over the age of twenty-one years and free from all disability, have exercised the privileges therein set forth, and in order to preserve the evidence thereof and to designate and fix titles to the lots hereinafter referred to in ourselves respectively;

NOW, THEREFORE, it is agreed by and between the undersigned hereto that in pursuance of and in accordance with said Will, the said T.C. Stone has selected lots numbers Nine (9) said C.R. Stone lots numbers Five (5) said R.G. Stone lots numbers Six (6) said J.B. Stone lots numbers TEN (10) said Charlie Stone lots numbers Seven and Eight (7-8) said E.E. Stone lots numbers FOUR (4) said Floride Stone Miller lots numbers TWO (2) and the said Fannie S. Cary lots numbers THREE (3) and that we do hereby ratify the provision of said Will and acknowledge the title to the lots above referred to as vesting absolutely in the parties respectively, as above stated;
