Fountain Inn, S.C.) Order to sell Real Estate.

An order having been passed in the above entitled matter on October 7, 1916 directing the foreclosure of certain mortgages on the land hereinafter described in favor of the Bank of Fountain Inn and V.M. Babb, directing that all the right and equities, including the right of dower, which is duly renounced on said mortgages, be forever barred; and

Whereas, it has appeared unto the Referee herein that certain farm land exposed for sale at Laurens, South Carolina, on salesday in November 1916, were bid in by and on behalf of the Trustee for the reason that it was not deemed that a satisfactory bid had been made; and

Whereas, the sale of the house and lot in the Town of Fountain Inn, in Greenville County, was not duly advertised as required by said order, in order to be sold on salesday in December, 1916; and

Whereas, it is highly desired that said property be sold during the present season of prosperity and before another crop is begun upon the farm lands and before there should set in another season of financial depression; now, therefore, it is Ordered, Adjudged and Decreed that the Trustee do proceed to advertise for sale the land described in said order of October 7, 1916, at public auction to the highest bidder for cash, and th-at such sale be absolute and without any duty on the part of the Trustee to bid upon the property; but that all sales be subject to confirmation by the Referee herein who may refuse to confirm on the ground of gross inadequacy of price, with the right on the part of the Trustee to sell any of said property at private sale before the date of public sale herein fixed and to withdraw said property from such public sale; and it is further Ordered, Adjudged and Decreed that the farm land herein ordered sold situate in Laurens County be sold at Laurens Court House, South Carolina, on the first Monday in January, 1917, between the hours of 11 o'clock A.M. and 2 o'clock P.M., at public auction to the highest bidders for cash, after due advertisement in the Laurensville Herald and the Laurens Advertiser, newspapers published in Laurens County: The following is a description of the property:

Tract No.1, All that tract of land containing 118.75 acres, more or less, bounded by lands of R.A. Nash, W.M. Nash, S.R. Gray and W.C. Deck, and having such metes and bounds as will appear by reference to survey of same made by W.M. Nash, on September 6, 1909, situate on Neeley Ferry Road in Laurens County, said District.

Tract No. 2. All that tract or parcel of land on waters of South Rabon Creek, containing 129 acres, more or less, being the same tract of land described in a plat made by W.M. Nash, Surveyor, on September 6, 1909, bounded by lands of Willis Coker and is also described in a deed recorded in the R.M.C. office for Laurens County in Deed Book 8, page 63, in said District.

It Is Further Ordered, Adjudged and decreed, that the trustee do sell the house and lot situate in the town of Fountain Inn, in Greenville County at Greenville, South Carolina, before the court house on the first Monday in January 1917, between the hours of 11 o'clock A.M. and 2 o'clock P.M., at public auction to the highest bidder for cash. The following is a description of the property:

Tract No. 3, All that lot or parcel of land on the east side of Main Street in the Town of Fountain Inn, and in Greenville County, bounded by Main Street, by the road leading to Holland's-
