

A.B. Thompson DEED TO Frances E. Thompson THE STATE OF SOUTH CAROLINA, COUNTY OF Greenville

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, A.B. Thompson in the State aforesaid in consideration of the sum of Twelve hundred (\$1200.00) DOLLARS, to me in hand paid at and before the sealing of these presents by

Frances E. Thompson (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said Frances E. Thompson, An undivided one-half interest in and to all that certain lot

of land in the City of Greenville, County and State aforesaid on the south side of Carrier Street (now Park Avenue) and having the following metes and bounds, to-wit: Beginning at a stake on Carrier Street 55 feet East of Alleyway; thence westerly with Carrier Street to iron pin corner of said Alleyway; thence South with line of Alley to a point far enough from the bank of the branch to leave a ten foot alleyway between said bank and the lot herein conveyed; thence with back line, so run as to make a straight line and leaving said ten foot alleyway; thence along line parallel with first mentioned alleyway to the beginning corner on Carrier Street; said lot bounded on the North by Carrier Street (now Park Avenue), on the south and west by ten foot alleys, and on the east by lot formerly owned by W.C. Beacham and H.J. Haynsworth, together with right on the part of the grantee, her heirs and assigns, to the use of said alley so as to not interfere however with the use of the said alley by the said W.C. A.B. Thompson (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said A.B. Thompson, All that certain lot of land situate in the City of Greenville, County

and State aforesaid on the south side of Carrier Street (now Park Avenue) and having the following metes and bounds, to-wit: Beginning at a stake on Carrier Street, 55 feet east of Alley way; thence westerly with Carrier Street to iron pin corner of said Alley way; thence South with line of Alley to a point far enough from the bank of the branch to leave a ten foot alley way between said bank and the lot herein conveyed; thence with back line, so run as to make a straight line and leaving said ten foot alley way; thence along line parallel with first mentioned alley way to the beginning corner on Carrier Street.
