Laton Barton, All that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, in O'Neal Township, and having the following metes and bounds, to-wit: Beginning at a stone on Gap Creek road, near St Paul church, and running thence S. 63-1/3 W. 16.05 chs. to a stone; thence S. 50-1/2 E. 22.00 chs. to a stone; thence N. 17 E. 6.00 chs. to a stone; thence S. 17 W. 8.90 chs. to a stone; thence S. 50-72 E. 8.60 chs. to a stone; thence S. 69 - 9.00 chs. to a stone in road; thence along same N. 33 E. crossing the Saluda Gap Road 12.80 to a stone in fork of two roads; thence along road to Bart Pennington's N. 11-1/2 E. 4.00 to a stone; thence leaving road N. 43-1/2 W. 25.70 to a poplar 3X0 in branch; thence S. 67 W. 15.00 to a stone; thence S. 33 E. 2.15 chs. to a stone thence S. 43 W. 3.00 to the beginning corner, containing one hundred acres (100) more or less, with the exception of the following tract sold to S.G.
