at and before the sealing of these presents by Josie L. Floydin the State aforesaid
in consideration of the sum of

(the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Josie L. Floyd "all that certain lot of Land, situate, lying and being in the State and County aforesaid, the Ward Two of the City of Greenville, more particularly described as the North side of East Park Avenue, and having the following lines, and bounded to wit: "Beginning at a point from the North side of East Park Avenue fifty-one feet and four inches (51' 4") from the northeast corner of the intersection of Park Avenue and Vanvoord Street, and running due South 20° 45' E. 172' to a point, thence N. 77 W. 30° to another point, thence S. 20° 45' W. 172' to an end point on the right described, thereby with Park Avenue S. 77 E. 50' to the beginning corner" being a part of the property conveyed to me by Joseph J. Rapp, by his Deed dated May 29, 1893, recorded in the Registered & Probate Department Office for State and County Clerks and in Vol. 19, p. 33B.

Receiving, however, its奴役, my heirs and assigns the right to use along with the property, the same and assigns for public uses or ingress and egress a four foot strip along the west side of the above described lot, to wit: a strip beginning at the southwest corner of said lot 101' 4" from the west of intersection of Park Avenue and Vanvoord Street, and running to a point N. 20° 45' E. 172' feet to a point, thence S. 77 E. 50° (4) feet to a point, thence over a line parallel with the first line 172 feet to Park Avenue, thence with Park Avenue four (4) feet to the beginning corner.

And I further convey to Josie L. Floyd, her heirs and assigns the right to use a similar strip on the east side of my lot adjoining the lot, along with the grantor, his heirs and assigns for the same purpose. This strip begins at a point on the north side of Park Avenue and southwest corner of the lot above described, distant 101' 4" from the northwest corner of the intersection of Park Avenue and Vanvoord Street and running thence N. 20° 45' E. 172' feet to a point, thence N. 77 W. 30° (4) feet to a point, thence along line parallel with first line 172' feet to Park Avenue, thence with Park Avenue S. 77 E. 50° (4) feet to the beginning. The intent of these last two paragraphs is to establish a long the west side of the lot herein first described and the east side of my lot adjoining same, a common drive-way eight feet wide.
