is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

W. D. Parish and T. C. C. Wolber, all those certain lots of land situated in Ward Four of the City of Greenville, County of Greenville, fore and ever, in as follows: two lots recorded in Block "C" of the Office for Greenville County, in Plat Book "C", Page, 117, lot No. 14, out lot next west side of Pois Street, Beginning at iron fence 65 feet east of the intersection of Pois Street and Oak-Lined Avenue, and running thence westwardly Pois Street 3.62°19' E. 65 feet to an iron fence corner lot No. 15 N. 32°34' E. 123.10 feet to another iron corner lot No. 8, thence northwardly iron fence of lot No. 8 to an iron fence corner lot No. 13, thence with line of lot No. 13 S. 34°50' W. 123.55 feet to the beginning corner lot No. 23 on the south side of Pois Street, Beginning at an iron fence 240 feet east of the intersection of Pois Street and Oak-Lined Avenue and running thence northwardly Pois Street S. 62°19' E. 60 feet to another iron fence corner lot No. 24; thence S. 34°50' W. 150 feet to another iron fence corner lot No. 29; thence with rear line of lot No. 29 N. 62°19' W. 60 feet to corner of lot No. 22; thence N. 34°50' E. 150 feet to another iron fence the beginning corner. Being the same lots of land so conveyed to the heirs of the signees by deed dated January 25th, 1916. Also agree that certain piece, parcel or lot of land situated in the County and State aforesaid about two miles west of the City of Greenville in Section known as "City View" and a part of the following described and bounded as follows: Beginning at a stake on the west side of Henderson Street joint therewith lot No. 61 and running thence N. 89°42' W. 150 feet to a stake, thence S. 0-30-1-50 feet to a stake, thence S. 89°42' E. 150 feet to a stake on Henderson Street, thence N. 0-30-50 feet to the beginning point and designated as lot No. 60 of Block "B" one plot made by W. A. L. Jones, Surveyor, and being one of the lots conveyed to me by deed dated February 11th, 1916, from V. T. Hedges, T. F. Herst and H. H. Hulbert, and recorded in the R. M. C. Office for Greenville County in Vol. 39, page 46.
