is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said A.W. Harrison, All that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, County and State aforesaid, being a part of the Land known as the City View Land Company's Land, and Commencing at a point sixty-three (63) feet from Smith Street and one hundred and fifty-four and 6/10 (154.6) feet from a New cut road; and running thence in an easterly direction towards Brandon Road, one hundred and twenty-six (126) feet, more or less, to a point one hundred and sixty-nine (169) feet from a new Cut road; thence in a southwesterly direction twelve (12) feet to a point one hundred and fifty-seven (157) feet from new Cut road; thence in a westerly direction toward Smith Street to a Point one hundred and forty-two feet and six inches (142' 6") from the new cut road, and twelve (12) feet from the beginning corner; thence in a Northeasterly direction twelve (12) feet to the beginning corner, and being a strip twelve (12) feet in width in the rear, being a portion of lot No. 11A and Lot No. 12 which were conveyed to me by Rebecca E. Decus, by deed dated Feb. 6th, 1914, and recorded in Deed Book Volume 28, at page 199, R.M.C. Office for Greenville County.
