KNOW ALL MEN BY THESE PRESENTS, That we, J. H. Ballenger, M. R. Ballenger, W. B. Ballenger, S. M. Ballenger, P. S. Ballenger, Mrs. S. E. Rector, Mrs. Fincis St. West and Mrs. E. Leonard of the County of Greenville in the State aforesaid for and for and in consideration of the sum of nine hundred DOLLARS, to John W Bell in head paid ~~and before the signing of these presents~~ by John W Bell of the County of Spartanburg in the State aforesaid,

(the receipt whereof ~~is hereby acknowledged~~), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

John W. Bell, One half interest in all that tract of land situated, lying and being in the State and County aforesaid on Suck Hole Fork of Middle Tyger River, having the following bearings:

Beginning on a P.O. running with road 350 52L to a stone; thence N. 52-3/4 E. 120 55L. to a W.O.; thence N. 60-1/2 230 W.O.; thence N. 18-1/4 E. 1.19 to a sweet gum; thence N. 12-1/2 12-1/2 W. 19.30 to a stone; thence N. 11-1/6 W. 25.75 to a chestnut S. 60-1/4 W. 1280 to a large poplar at the branch; thence with the branch to a X; thence S. 1/2 W. 3.26 to a chestnut; thence 18-1/2 E. 925 X; thence S. 38-1/2 W. 22.86 to a stone; thence S. 60-1/4 W. 15.34 to a posimmon X; thence S. 8-1/2 E. 1720 to the beginning X and containing one hundred fifty-nine 3/4 acres, more or less, including one half interest in all the Mill and Machinery on said tract of land and bounded by lands Nathaniel Rector, S.
