Greenville, South Carolina, on the twenty-third day of January, 1919 it was resolved that the stockholders approve of said sale and of any action necessary to effectuate same, and, Whereas, at a meeting of the Board of Directors of Saluda River Lumber Company held February 4th, 1919, it was resolved that the sale should be consummated for the consideration herein provided and that a Deed to said property be executed to said The Saluda Corporation for the consideration hereinafter named, and,

Whereas, the Vice President and Secretary are the proper officers to execute this Deed on behalf of Saluda River Lumber Company,

Now Therefore Know All Men By These Presents, That, Saluda River Lumber Company in the State aforesaid in consideration of the sum of Two Hundred and Forty-Two Thousand. Three Hundred and Twenty-Five (\$242325) Dollars to it in hand paid at an before the sealing of these presents by The Saluda Corporation in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said The Saluda Corporation.

All of the property of Saluda River Lumber Company, in the County of Greenville, State of South Carolina, more particularly described as follows:-

J. Walter Gray and Furman University Tracts.

All that tract of land in the County of Greenville, State of South Carolina, Cleveland Township, lying to the South of the Middle Saluda River to the East of Matthews Creek, lying to the North and East of the Furman University, Caesar's Head property containing Ten Hundred and Thirty-Six (1036) acres and described on a plat of the J.Walter Gray tract known as "A-I" prepared for The Saluda Corporation by Howard Wiswall in April, 1918, reference to which said plat is hereby craved for a complete and accurate description of the area, metes, and bounds of said property.

All of the merchantable timber, that is to say all of the timber standing or lying at the time. of operation twelve (12) inches or more stump diameter outside of the bark, four (4) feet above the ground. The timber to include all trees suitable for lumber, pulp wood, acid timber, railroad ties, twlephone and telegraph poles, fence posts. The restriction as to size not applying to Jack Pines nor to such trees as the grantee may require for its own use for railroad ties, telephone and telegraph poles, fence posts, necessary in the construction of its railways,

tramways, telephone and telephone lines and fences on the following property described on the aforesaid plat of Howard Wiswall, to-wit:-

- (a) One hundred and ten (110) acres on Oil Camp Creek in said County, Township and State, lying to the East of the said Caesar's Head property now owned by Furman University, between a road marked on said plat and the Eastern boundary of the Hagood grant.

Less the portion thereof conveyed by Saluda River Lumber Company to Furman University by deed recorded in said office in Book 32, page 118. Also to convey the timber rights, ways, privileges and property conveyed by Furman University to Saluda River Lumber Company by the aforesaid DeeD, recorded in said office in Book 32, page 109.

The Grantor herein however does not warrant the title to Two Hundred and Twenty-Six (226) acres of the property and rights herein conveyed.
