by acknowledged), have Granted, Bargained, Sold and Released, unto the said Dr. J. P. Brown, all that certain piece, parcel or lot of land situated, lying and being in the City of Greenville, County and State aforesaid in Ward Four of the City of Greenville, on the north side of Washington Road, and being more fully described as follows: Beginning at a certain point at the corner of Miss. Robert F. Bower lot line on the south side of Washington Street and running thence N. 61.15 E. 143 feet, more or less, to a stake on the South Side of Washington Street, corner of Patterson's lot line, thence S. 41.05 E. 165 feet with the said line to stake on right of way of C.
