in consideration of the sum of ten dollars and other consideration in the State aforesaid  
 to me in hand paid at and before the sealing of these presents by H. S. Stokes DOLLARS  
 (the receipt whereof is here-  
 by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

H. S. Stokes, All that certain piece, parcel or lot of land situated lying and being in Greenville County and State aforesaid and near the Cross of Greer, and having the following metes and bounds to-wit: - Beginning at an iron pin on the unnamed street and runs with said street S. 11 1/2° W. 40 ft., to an iron pin; thence S. 78 3/4° E. 180 ft. to an iron pin; thence N. 11 1/2° E. 180 ft., to an iron pin; thence N. 73 1/2° W. 180 ft., to the beginning corner being known as Lot 4 on plat of land called Brookville near Greer, S. C.

Bound by lands of Brock Shillard and others, and being the same lot of land conveyed to me by J. W. Nearee, by deed dated Feb. 17th 1914, and recorded in office of P. M. C. for Greenville County in Vol. 27, page 512.
