by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said D.L. Johnson, All that certain piece, parcel or tract of land situate in Butler Township, in the County and State aforesaid, containing one hundred and twelve (112) acres, more or less, and having the following metes and bounds, to wit: Beginning at a stake corner Jean V. Latimer; thence with the line of the said Jean V. Latimer, N. 4-1/2° E. 3,950 feet to a stake; thence S 77-1/4° E. 1,250 feet to a pine; thence S. 15-1/4° W. 1,030 feet to a stake; thence S 45° W. 250 feet to a stake; thence S-17-1/2° W. 350 feet to road to Greenville; thence S. 17-1/2° W. 950 feet to a sweet gum; thence S 5-1/2° E. 1,200 feet to a stone corner Latimer lands; thence N 89-1/2° W. 1,159 feet to the beginning corner. In consideration of the sum of Five Dollars and other valuable consideration DOLLARS to us in hand paid at and before the sealing of these presents by C. O. Hobbs (the receipt whereof is here-

by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said C. O. Hobbs, All that piece, parcel and lot of land situate, lying and being in the City and County of Greenville, and on Hampton Avenue, and having the following metes and bounds, to wit:-Beginning at an iron pin on Hampton Avenue, and running thence N. 33-1/4° W. sixty feet to an iron pin on said Avenue; thence N. 54-1/4° E. one hundred and one and one-half feet to a pin on Pine Street; thence along Pine Street S, 3-1/2° E. seventy and one-half feet to a pine on Pine Street; thence N. 56-1/4° E. one hundred and thirty-five feet to the beginning corner, less a strip four and one-half feet wide which was sold by E.W.Carpenter to J.O. Raines, as set forth in deed bearing date September 29th. 1911, and recorded in the R.M.C. Office for Greenville County in Book 13, at page 437. This being the same lot of land conveyed to us by T.F.
