Tract No. 2, of the E. S. Hamby estate, according to a plat and

1915, and containing twenty-two (22) acres, more or less, and
having the following meter and bounds, to wit: Beginning
at an iron pin at Northwest corner of Tract No. 3 and running
thence S. 82 W. 2.41 to stone; thence N. 64 W. 7.78 to an iron pin
corner of Tract No. 1; thence along line of Tract No. 1 S. 63 W. 28.00
to an iron pin in line of Tract No. 7; thence N. 61 E. 12.00 to an
iron pin; thence N. 6 E. 19.30 to iron pin at the beginning
corner."
